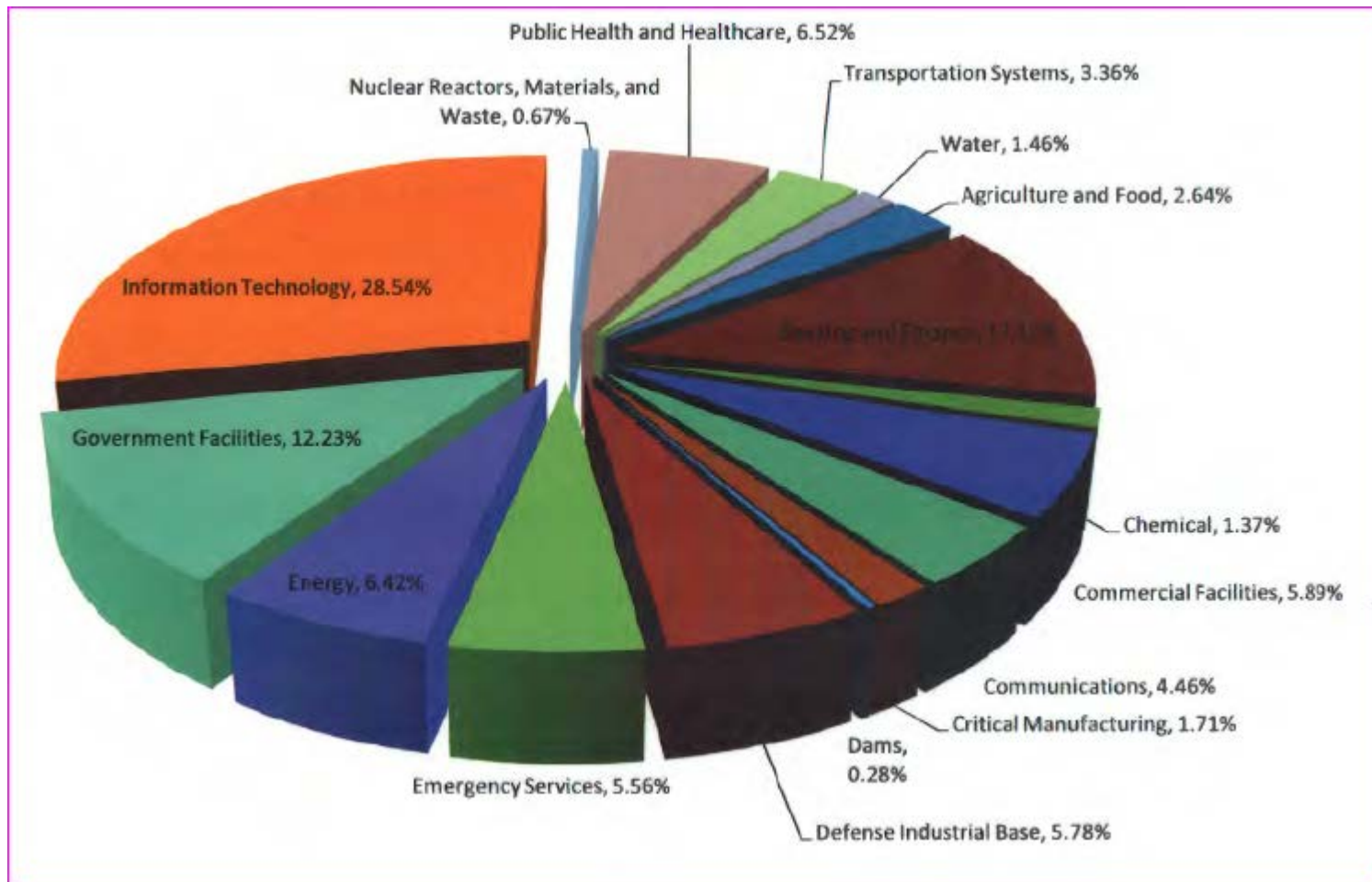
# FBI InfraGard Fast Facts

- Augments the NIST Cybersecurity Framework Initiative under Presidential Executive Order 13636 and Presidential Policy Directive (PDD-21)

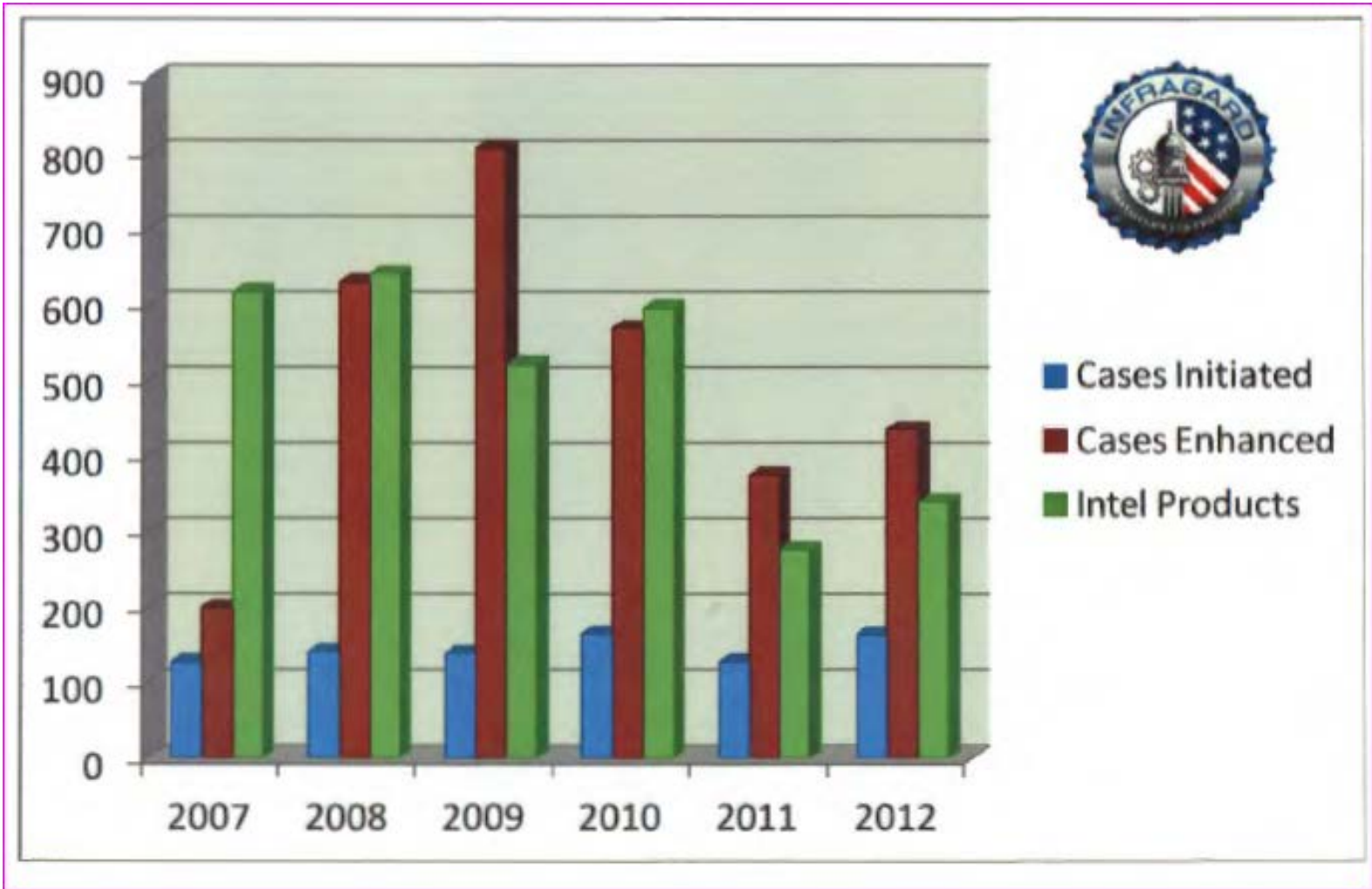
